

Minutes of meeting of SCL Pension Adalat-2020 held on 31.12.2020**Present:**

1. Pension Adalat meeting started at 2.30 PM in the office of Head, Accounts/IFA. Chairman welcomed the Members and invitees to the Pension Adalat – 2020.
2. Member Secretary apprised that there are 101 Pensioners (including 16 VR cases) & 16 Family Pensioners (total 117) getting pension under SCL PFs & Pension Scheme 2007.
3. Further it was informed that, initially the Adalat was planned to be held in September, 2020, but due to COVID-19 situation, the same could not be held. Presently, Adalat is being convened in view of Communication received from Pension & Pensioners Welfare Department dated 14.12.2020 & DOS letter 18.12.2020 for which the notices were published in leading newspapers on 26.12.2020 and also uploaded on SCL's official website.
4. It was requested to the pensioners through above notices for submission of their grievances, if any to SCL through e-mail/by post to be addressed through whatsapp video call. However, SCL had not received any grievances from its pensioners/family pensioners till the due date i.e. 30.12.2020.
5. The minutes of the Pension Adalat-2019 held on 23.8.2019 were read out to the members and it was noted that no action is pending.
6. Member Secretary informed that CHSS Accounts in association with PPG have started sending email messages to Pensioners/Family Pensioners who have provided their email ids, informing them status of reimbursement of CHSS bills submitted by them.
7. Member Secretary also informed that on the initiative of Pension Section-P&GA, Pensioners Portal is under development stage by PPG. Upon hoisting of Pensioners Portal, It will be informative for the Pensioners/Family Pensioners about new developments/rules & regulations concerning them.




