**Minutes of Meeting of SCL Pension Adalat-2017 held on 9.8.2017**

Shri N.P.Singh informed the members that upon Superannuation of Head Accounts/IFA/Chairman, SCL PFs & Pensions Trust on 31.7.2017 and till joining of New Head Accounts/IFA, Shri Manoj Agarwal, Sr. Accounts Officer is looking after the functions of Accounts Division. Accordingly, the Members of SCL Pension Adalat were welcomed for making it convenient to attend the Pension Adalat-2017.

2. Shri N.P.Singh informed the Adalat that there are 57 Pensioners & 12 family pensioners (including 14 VR cases) getting pension under SCL PFs & Pension Scheme, 2007. There is no grievance received by the due date i.e. 8.8.2017 either in response to SCL Notice published in the Newspapers on 3.5.2017 or otherwise from any of the SCL pensioners.

One suggestion received from Shri B.L.Sharma on 8.8.2017, regarding providing intimation of pension amount with details of deductions to Pensioners. Shri Manoj Agarwal, Sr. Accounts Officer informed that necessary action on the suggestion so received would be dealt with by Accounts-Pension Section in due course of time. The Adalat noted the same.

Shri N.P.Singh also informed about the suggestion during the last Pension Adalat held on 3.8.2016 that there should be a Focal Point or Pension Cell in SCL where the SCL Pensioners/Family Pensioners could communicate their pension related issues (including proposed savings for the purpose of income-tax deductions etc.) or suggestions, if any.

In response, P&GA, SCL had sent the email dated 31.3.2017 giving Name of the Nodal Officers and Phone Numbers to all pensioners for their information. The Adalat noted the same.


