

**Minutes of meeting of SCL Pension Adalat-2019 held on 23.8.2019**

1. Chairman welcomed the Members and invitees to the Pension Adalat – 2019.
2. Member Secretary apprised the Pension Adalat that there are 78 Pensioners (including 15 VR cases) & 16 Family Pensioners getting pension under SCL PFs & Pension Scheme 2007.
3. Adalat was informed that, initially the Adalat was planned to be held on 4.9.2019, for which the notices were published in leading newspapers and also uploaded on SCL's official website. However, the same was preponed to 23.8.2019 on GOI's direction and notices were published again in the newspapers and uploaded on SCL's website.
4. It was requested to the pensioners through above notices for submission of their grievances, if any to SCL through e-mail/by post. However, SCL has not received any grievances from its pensioners/family pensioners till the due date i.e. 21.8.2019.
5. The minutes of the Pension Adalat-2018 held on 29.8.2018 were read out to the members and there is no action pending on that.
6. Sh.S.B.Sarna, Representative of SCL Pensioners, commended the work started by Pension Cell for commencing sending the details of monthly Pension from July, 2019 onwards through email to the Pensioners as was suggested by him during the last Pension Adalat.

On a query by Sh.S.B.Sarna regarding revision of Pay and Pension on DOS order for enhancement of DA it was intimated by Member Secretary that the arrears pertaining to pay revision has already been credited to the retiree's bank accounts during this month and revision of Pension is under process.
