	i. Three similar works each costing not less than 40% of the estimated cost i.e. Rs. 13,46,480/-(or) ii. One similar work costing not less than 80% of the estimated cost i.e Rs. 26,92,960/-	supported by TDS (Tax Deduction at Source) certificate.

	ii. The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to last date of submission of bids.

Should have had average annual Financial turnover not less than 30% of the estimated cost (i.e.Rs.10,09,860/-) of the work during the last three years ending 31st March of preceding year (i.e.2024)	Chartered Accountant certificate for the Annual financial turnover and balance sheet showing Profit & Loss.
c.	Should not have incurred any loss in more than two years during the last five years ending 31st March,2024	
d.	Should have a solvency of 40% of the estimated cost of the work (i.e Rs. 13,46,480/-)	Current solvency certificate from any Scheduled Bank not more than 6 months old.
e.	The bidding capacity of the contractor should be more than the estimated cost of the work put to tender. The bidding capacity shall be worked out and declared by the tenderer and enclosed with the request for tender document based on the formula: (AxNx2)-B where, A- Maximum value of work executed in one year (maximum turnover in one year) during last 5 years at current price level taking into account the work completed as well as work in progress.
